AN ORDINANCE OF THE CITY OF JEFFERSON, MISSOURI, AMENDING SECTION 19-401 (STREETS AND HIGHWAYS), SCHEDULE (O), (PARKING TIME LIMIT ZONES) OF THE CODE OF THE CITY OF JEFFERSON, BY MODIFYING PORTIONS OF DUNKLIN STREET AND JEFFERSON STREET; AND SCHEDULE (N), (PARKING METER ZONES AND MONTHLY PARKING FEES) PERTAINING TO LOT #31.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF JEFFERSON, MISSOURI, AS FOLLOWS:

Section 1. Section 19-401, (Streets and Highways), Schedule O. (Parking Time Limit Zones), Time Zone C (one-hour limit), of the Code of the City of Jefferson, Missouri, is hereby modified as follows:

(c) Time Zone C (one-hour limit) by the deletion of:

~~Jefferson Street: between Dunklin Street and a point two hundred fifty feet south of the centerline of Highway 5063.~~

~~Dunklin Street: the south side of the 100 block, between Jefferson Street and Madison Street.~~

Section 2. Section 19-401, (Streets and Highways), Schedule O. (Parking Time Limit Zones), Time Zone E (two-hour limit), of the Code of the City of Jefferson, Missouri, is hereby modified as follows:

(c) Time Zone E (two-hour limit) by the addition of:

**Jefferson Street: the east side between Dunklin Street and E. Cedar Way.**

**Jefferson Street: the west side between Dunklin Street and a point being 170 feet north of the north side of E. Cedar Way.**

**Dunklin Street: on both side of the 100 block between Jefferson and Madison Streets.**

Section 3. Section 19-401, (Streets and Highways), Schedule N. (Parking Meter Zones and Monthly Parking Fees), Subparagraph (a), (Parking Lots and Facilities), of the Code of the City of Jefferson, Missouri, is hereby modified as follows:
