TO OBTAIN A LICENSE:

1. You must have a criminal background check at the Missouri State Highway Patrol, 1510 East Elm Street, JCMO (annex building, first floor). The cost is \$20.00 (money order, personal or company check, NO CASH). They will give you paperwork that will be kept on file with your application in our office. (8:00 - 4:00 Monday-Thursday, NO FRIDAY)
2. If you plan to go door-to-door or business-to-business, we must have two pictures - one to attach to the license document, the other will be attached to your application and retained in our files.

If you plan to park in a set location you will not need pictures - but you must provide written approval from LANDOWNER that it is acceptable for you to locate on this property. You must notify this office each time your location changes and bring in written permission from the LANDOWNER.

3. Come to the John G. Christy Municipal Building, Finance Dept., 320 East McCarty Street, JCMO and fill out the application. You will be requested to provide information about the organization you work for and vehicle identification information.

NOTE: If food items are a part of your wares you must first have signed authorization from the Community Development, Environmental Services Division that you meet the requirements established in the health code.

NOTE: You may also inquire at Community Development on any location that you wish to be in making sure you are not in violation of City ordinances.

4. If you have met the above requirements, your application will be processed, payment is expected at the time the application is made.
