- Game time is forfeit time. Each team must have at least four players ready to play at game time or the **first game** will be forfeited. Ten minutes will be allowed to elapse before the second and third games are declared forfeits. When, for any reason, a team is reduced to less than four players, the match will be forfeited.
- If a team forfeits a match there is a \$9.50 reimbursement fee payable to the team manager of the opposing team before the team will be allowed to play its next match. Prior notification of Parks and Recreation no longer exempts teams from paying the reimbursement fee.
- League standings will be kept by games. All three games of each match will be played as rally scoring to 25. Games must be won by two. There is a 27 point cap.
- Substitutions may enter the game in the center back position only.
